We also waive the need for a formal court hearing or the attendance of both of us at a court hearing and, consistent with that, we waive service of notice of all hearings necessary to approve this Joint Supplement Petition.

WHEREFORE, we request that the Court enter an Order approving these modifications without the need for formal delivery of a Notice of Hearing to either party, and that the formal appearance of one or the other party in Court for hearing on this Joint Petition is sufficient.
