 - Owner's Authorization for Property Manager (if needed)
 - ➤ 1 envelope w/2 stamps addressed to the tenant
 - Civil Cover Sheet

II. TO OBTAIN A JUDGMENT:

*PLEASE NOTE: If no response by tenant, a NON MILTARY AFFIDAVIT must be filed

- After either 5 days or 20 days of service by the Sheriff (depending on the type of Complaint you have filed), the Landlord may Motion the Court in writing to request a Final Judgment and Writ of Possession. However; if a Hearing and/or Mediation has been scheduled, you may want to wait until you attend court
- Once the Final Judgement has been entered, you will need to forward the Writ of Possession and fees to FCSO
